



ITCP Health Equity Learning Series 2023-2024



Engaging In Health Equity Work

The Center for the Study of Social Policy (CSSP) and ZERO TO THREE (ZTT) are pleased to offer a virtual learning series to Infant Toddler Court Program (ITCP) state teams and their partners as they advance the critical work of health equity. This series is designed to provide **state teams and partners** with a foundational understanding of health equity and racial equity, and how to develop anti-racist approaches in their work. It will also support states as they work to address the goals from their Disparity Impact Statements.

Advancing Action

The learning series sessions are listed below, and will be interactive, with time for small and large group discussions. The goal is for each session to build on participants' current knowledge, help participants identify opportunities to advance health equity in their own work, and set them up for success as they think about advancing their health equity vision, and scaling impact and sustainability of their health equity strategies.

Schedule and Session Descriptions

1. Foundational Racial and Health Equity Concepts, July 12, 2023, 1:00 - 3:00 PM ET
A foundational training on health and racial equity terms and concepts, and an opportunity to review data related to health inequities and explore root causes. The session will help participants apply and use shared language to advance health equity and increase impact for priority populations.
2. Understanding the History of Racism in Health and Other Systems, September 13, 2023, 3:00 - 4:30 PM ET
Participants will learn how racism shaped our past and current health systems and led to current disparities based on race. They will also hear examples of how communities have advocated for change and reflect on initial strategies for improving systems.
3. Anti-Racist Strategies to Advance Health Equity, November 9, 2023, 3:00 - 4:30 PM ET
Participants will understand how data can be used to drive changes in systems, and explore anti-racist strategies that can advance health equity through practice and policy changes. They will also discuss strategies they are currently implementing or exploring, and identify partnerships and other opportunities to advance their efforts.
4. Parents as Partners to Advance Health Equity, February 8, 2024, 3:00 - 4:30 PM ET
Participants will learn strategies to center parent and family voices in health equity efforts, better understand how to integrate and sustain parent and family leadership, and hear from parent leaders who are helping to change systems. Participants will also identify strategies they could employ to increase parent and family participation in their work.
5. Developing a Health Equity Agenda, April 17, 2024, 3:00 - 4:30 PM ET
Participants will learn about principles and strategies to inform policy and practice change, learn about anti-racist policies and practices, and identify specific areas to advance within their state. Participants will revisit their ongoing health equity strategies (or plans to implement strategies) and consider refinements, new or enhanced areas of focus, or additional strategies to advance their goals.
