

## **Iowa Legal Aid Community Schools Project**

Iowa Legal Aid provides free civil legal services to eligible families within Des Moines Public School District. This year, they will hold free and confidential on-site legal clinics at Monroe and King Elementary Schools, and East High School – however, any district families can utilize the clinic hours or make an appointment to meet with the clinic staff.

Iowa Legal Aid provides support for civil legal cases which can include cases about housing, income instability (e.g., unemployment or expungements), domestic violence and other family law matters such as guardianship, custody modifications, divorce, etc.

Iowa Legal Aid partners with stakeholders and community resources to deliver a full spectrum of services to assist families in achieving stability. Along with having a student enrolled in the district, eligibility for services includes meeting income guidelines and legal status restrictions.

Monroe Elementary School:

First and Third Tuesday of each month, 8:30 a.m.-3:30 p.m.

King Elementary School:

Second and Fourth Wednesday of each month, 8:30 a.m.-3:30 p.m.

Edmunds Elementary School:

First Thursday of each month 7:00 a.m. – noon, and Third Thursday of each month 2:00-5:00 p.m.

Park Avenue Elementary School:

First and Third Wednesday of each month, noon -3:00 p.m.

East High School:

First Wednesday of each month, 9:00a.m.-1:00 p.m.
